# b. Philadelphia State Court Peripheral Neuropathy Litigation, including report on Bryant trial setting

The *Bryant* case is set for jury selection on September 28, 2018, with trial to start on October 1. 3 more cases have been filed in Philadelphia state court. Since they were filed after the *Bryant* case, they have not yet been set for trial.

## c. Dismissal of Shepherd case

Stipulation of dismissal was entered today.

#### **II. Scope of Case-specific Expert Reports**

The parties indicated that there is a dispute regarding the scope of casespecific expert reports. Plaintiffs have 7 days to file a brief on this issue; Defendants have 10 additional days to respond.

#### III. Timing and Structure of Daubert Hearing

The Court will hold a 1-day hearing on Defendants' *Daubert* motion. The Court will endeavor to schedule this hearing for September 13, 14, or 17, and will notify the parties shortly.

## **IV. Motion for Continued Sealing**

The parties have submitted a proposed order regarding continued sealing, which the Court will sign.

## V. Phase II Bellwether Plan

The Court believes that a second phase of bellwether selection should begin soon. The Court will allow parties to talk for two weeks. At that time, the parties are to send a letter (jointly or separately) indicating points of contention. The Court will resolve any outstanding issues.

#### VI. Motions to Withdraw

Court will grant the two motions.

The next status conference will be held in conjunction with the Daubert hearings.
