Maintaining your CSO Account

- Attorney's responsibility to maintain account
- All Personal Information (address, phone number, etc.) is maintained through PACER
- Primary email address is maintained in PACER
- Secondary email addresses are maintained in ECF
 - Suggest adding at least 1-2
 - Support staff email addresses
- All email addresses receive one free look

- Login & password constitutes signature
 - Do not need to upload ink signature
- Affix on behalf of 3rd parties & notaries
 - Retain ink signed original
- Parties have 14 days to object to s/signature



Creating PDFs for Uploading

- Convert all documents to PDF
- 35 MB or less
 - If >35 MB, break into smaller PDFs
- Multiple NON-SEALED exhibits may be saved to one PDF
 - Describe each attachment uploaded
 - *Exhibits A–D or Exhibits 1-5*
 - Create index of exhibits or list within affidavit
- Include searchable text when possible
- PDF or PDF/A
- File Proposed Orders in ECF **and** email to chambers in word processing format, e.g., DOCX



Notice of Electronic Filing (NEF)

- Automatic e-mail notice of case activity
 - Identifies parties not receiving electronic notice
- Attorneys of record and secondary email addresses each get one free copy of all documents filed electronically
- Pursuant to Fed. R. Civ. P. 5(d)(1)(B), *Certificate of Service*. No certificate of service is required when a paper is served by filing it with the court's electronic-filing system.
- Manually serve parties not receiving electronic notice via ECF
- NEF is available for 15 days

Electronic Case Opening

- Attorneys open civil cases in ECF
- Exceptions:
 - Sealed cases
 - Whenever the filer is unable to open cases
- To file a new case conventionally, submit to the Clerk of Court:
 - Initiating Documents in Paper
 - Payment to the Clerk of Court
- New cases can be filed anytime
 - Recommend opening during business hours for 1st time filers



Initiating a New Civil Case

Attorney/Filer

Opens case

Files complaint/initiating document



Court

Reviews case opening

Randomly assigns judges

Issues electronic summons



Attorney/Filer

Serves Summons & Complaint

Files Returned Summons Executed/Unexecuted



Electronic Case Opening

- Review Civil Case Opening Resources
 - See court's website > NextGen ECF > Reference Guides and User's Manuals > [Civil Case Opening](#)
 - New Case Checklist
 - Party Name Guide
 - Cause of Action list
- Prepare before filing
 - Civil Cover Sheet
 - Initiating document
 - Exhibits saved as separate PDF files
 - Payment method
 - Credit/debit card
 - Bank account routing numbers



Electronic Case Opening

- Documents filed separately
 - **Do not** attach to initiating document:
 - *Application to Proceed in District Court without prepaying Fees or Costs*
 - *Answer to Complaint*
 - *Rule 7.1 Corporate Disclosure*
 - *Request for Waiver of Service of Summons*



Pay.gov

- Secure electronic payments to federal government agencies
- Use credit/debit card or banking account
 - Save billing info in your PACER user account
- See court's website > CM/ECF > Electronic Payments
 - Procedure Guide
 - Pay.gov FAQs
 - Requesting Refund for Payments made in Error
 - Prepare *Request for Refund* form
 - File form in ECF with event *Request for Refund of Fees Paid Electronically*



8 Basics Steps to File in ECF

- Select the event
 - Use the most specific event before a generic event
- Enter the case number
- Choose the party filing the document
- Browse to find your .pdf document
- Add any necessary attachments
- Modify docket text as needed
- Commit the transaction to ECF
- Receive receipt of filing



Filing Documents Under Seal

- All documents filed in a civil case, whether sealed or not, must be filed electronically on ECF.
 - Exception: New sealed cases must be filed conventionally.

- The **Conventional Filing Placeholder Form** has been updated as it no longer is used for sealed documents.



Viewing Restricted Filings & Cases

- Certain case types and documents are restricted to specific users
 - Social Security and Immigration cases
 - Restricted to case participants only
 - Sealed Documents
- To view free look from NEF
 - Prompt for PACER login and password
 - ECF confirms user has authority to view document
 - Users without access to view document receive a message instead of viewing the document



Documents Filed in Error

Call ECF Help Desk Immediately!

- Correct case with wrong attachment:
 - Docket entry marked “Filed in Error”
- Incorrect case
 - Docket entry marked “Filed in Error”
 - Document restricted to court only
- Confidential document
 - Document temporarily sealed
 - Follow Local Rule 5.6 and Sealed Civil User’s Manual



Redaction of Personal Identifiers

- Must redact personal identifiers under Fed. R. Civ. P.5.2

Personal Identifier	Redacted Personal Identifier
Social Security Number	XXX-XX-6789
Financial Account Number	XXX-XX-X4-321
Name of Minor Child	J.D.
Date of Birth	2004

- May file under seal without leave of court, either:
 - Unredacted document
 - [Reference List of Personal Identifiers Form](#)
 - See court's website > CM/ECF > Forms > ECF Forms
- The procedures set forth in Local Rule 5.6 need not be followed by a party who is merely redacting personal identifiers in compliance with Fed. R. Civ. P. 5.2 or LR 5.5.



Transcripts

- Transcripts are restricted for 90 days.
 - ▶ If redaction of **personal identifiers** is necessary (Refer to LR 5.5, Fed. R. Civ. P. 5.2):
 1. Within 21 days of the transcript's filing:
 - File a *Statement of Redaction*
 - See court's website > > Court Forms > Transcript Forms
 - **Do not disclose** personal identifiers on the statement
 - ▶ **NOTE:** The *Statement of Redaction* is only used to redact personal identifiers.

Helpful Reports & Tools

Utilities tab

- Transaction Log
 - Log of transactions made in CM/ECF
- Case Mailing Information
 - Lists of parties receiving electronic or manual/paper noticing

Reports tab

- Internet Payment History
 - List all fee payments made by attorney

Search

- Find specific filing events



Troubleshooting Tips

- ▶ Press **F5** to refresh page
 - ▶ Blank screen
 - ▶ Missing menu items
- ▶ Clear Cache
 - ▶ Internet search for “clear internet cookies [your browser]”
- ▶ Restart browser
